## Agenda Item 1 - Review Agenda

The Board reviewed the agenda and no changes were made.

# <u>Agenda Item 2 - Legislative Project Update</u>

The Board had called the teleconference to discuss an issue that was brought up when the State Society had their meeting to review the proposed changes to the statutes. There were question about AS 08.04.360 and AS 08.04.380. It was noted that Lisa Rogers had completed a detailed review of the project and found some required edits; those were already provided to Mr. Cox, who also participated in the committee meeting.

AS 08.04.360 needs review for Board intent. Should it really be one office only? Does this make sense in this day and age? The Board also needs to discuss AS 08.04.380 regarding a waiver; should this section just be repealed? Ms. Beltrami noted that if you supervise remotely within Alaska, you can supervise remotely outside of Alaska. Ms. Schmitz stated that she would be uncomfortable with a CPA firm that had no CPA in Alaska. It was noted that with firm mobility, they are coming in to do work, but not set up an office.

Upon a motion duly made by Mr. Rulien seconded by Mr. Hogue, and approved unanimously, it was:

RESOLVED to amend AS 08.04.360 to read: Each office established or maintained in this state for the practice of public accounting shall be under the direct supervision of an individual physically present who holds a license in this state. The supervisor may be a sole proprietor, partner, principal, member, or staff employee. A supervisor may serve in this capacity at any office in this state.

Upon a motion duly made by Mr. Hogue seconded by Ms. Beltrami, and approved unanimously, it was:

RESOLVED to repeal AS 08.04.380.

# Agenda Item 3 - Application Review

The Board had access to applications being considered via OnBoard.

Upon a motion duly made by Ms. Beltrami seconded by Ms. Smith, and approved unanimously, it was:

RESOLVED to approve the firm permit of Forensic & Valuation Services Ltd.

Upon a motion duly made by Ms. Beltrami seconded by Mr. Rulien, and approved unanimously, it was:

RESOLVED to approve the Out-of-State firm permit of BPM LLP.

Upon a motion duly made by Mr. Rulien seconded by Mr. Hogue, and approved unanimously, it was:

RESOLVED to approve the Out-of-State firm permit of Gilbert CPAs.
