#### Agenda Item 2 - Regulation Project

The Board had called the teleconference to continue review of draft regulation updates to allow for continuous testing. An updated version of the project dated 4/3/2020 had been sent to the Board for their review. Mr. Tegeler wanted to confirm that NASBA had been contacted about this project. Ms. Schmitz confirmed that NASBA was involved and the draft being presented was an

Upon a motion duly made by Mr. Rulien seconded by Ms. Beltrami, and approved unanimously, it was:

RESOLVED to approve the draft regulation for 12 AAC 04.235 dated 4/3/2020 to be sent out for public comment; to interested parties only and to only accept written testimony.

It was noted that Board had requested that this file be sent to investigations and was returned with no findings.

Upon a motion duly made by Ms. Smith seconded by Mr. Rulien, and approved unanimously, it was:
