The administrative law judge who served as mediator will be invited to remain with the Board during the deliberative session.

I move that the board accept the mediated agreement between Dr. Schweigert and the State of Alaska


Motion moved by Dr. Walter Campbell and motion seconded by Dr. Timothy Kanady.
