SEAPA – Training Program Cha	anges: Volume II			
	The Southeast Alaska Pilots' Association's (SEAPA's) training chair, Captain Paul Merrill, provided the board with SEAPA's Volume II training program changes. He informed the board that there were changes to the following areas of their training manual (Volume I most of which aim to better match training with the increased size of vessels in the area.  1. Updated deputy tonnage levels to match current regulations 2. Increased transit requirements 3. Increased amount of work required in glacial ice conditions 4. Modernized record keeping procedures 5. Trainees and Apprentices are now required to stand some long watches to gair experience over more of the region 6. Apprentices are no longer required to complete their training at the conn within three years of taking the core exam 7. Apprentices are no longer required to observe for 12 months before training at the conn 8. Eliminated the 'Train the Trainer' requirement for prospective training pilots (it will continue to be encouraged, but we don't want to hold up a training pilot endorsement if the course is not available)  Mr. Habeger asked Captain Merrill what the difference was between an assessed movement and a vessel movement when talking about tonnage upgrades in their trainin manual, Volume II. Mr. Bay reminded them that their first regulations project included changes to 12 AAC 56.025, to amend requirements to allow applicants additional time to submit and complete applications and the application requirements, which would allow for faster processing times, changes to 12 AAC 56.070, to remove an outdated examination reference and the requirement of examinations to be offered at a meeting of the board, and changes to 12 AAC 56.080, to amend license renewal requirements related to the number of days a deputy marine pilot must have spent piloting vessels during the previous licensing period. He reminded them that their second regulations project included an amendment to 12 AAC 56.028 to allow deputy marine pilot candidates/trainees the option to finish certain training requirements at a manned model facility. The board motioned to adopt their first regulations project.

Don Habeger, who was new to the board and was not present at the time of the creation of the regulations project, asked Mr. Bay how faster processing times would be achieved in regard to the changes to 12 AAC 56.025. Mr. Bay informed him that the current deadline for submitting supporting documentation for both the Local Knowledge Examination and the Core Examination was 60 days before the date of each examination, and that the changes to 12 AAC 56.025 would cut that deadline in half, to 30 days. He said that there were often times that candidates for both exams were waiting at least a month to take the exams. The delays of taking the exams, he said, had resulted in gaps of training time on the water and the ability for candidates to help their respective pilot associations. Discussion:	The board's investigator, Patrick Kase, provided the board with their Investigative Report.  He informed the board that, for the period of April 19, 2024, thru July 22, 2024, there were three open cases and that one of them had closed since July 22 <sup>nd</sup> . Chairman Thayer asked if they could get an update on the open contested license denial case from 2019, to which Mr. Kase said that it was in litigation, and he would need to ask Chief Investigator Erika Prieksat. Chairman Thayer asked him if he could get an update on exactly where it is in the litigation process for their next meeting, to which he said yes. With nothing left to discuss, the board moved onto their next agenda item.

Fiscal Reports: FY24 Q4				
Brief Discussion:	The division's Administrative Operations Manager, Melissa Dumas, provided the board with their FY 24 4 <sup>th</sup> Quarter Fiscal Report. She informed the board that they had a large surplus in revenue, but that it would continue to decrease over time because of the licensing fee reductions (\$1,500 to \$700) that took place in October 2022. She reminded the board that, in addition to the money received from foreign pleasure crafts, the board would also be receiving additional revenue because it was a renewal year. Captain Sinclair asked if they were anticipating a change to their upcoming renewal feels, to which she said no. Chairman Thayer informed her that the board had asked the division to get the potential legal costs of their case that is currently in litigation. Mr. Mew asked her what advertising on their fiscal report entailed, to which she said it was the cost of publicly noticing their meetings. Captain Sinclair asked why the amount of legal costs were likely lower than they should be, to which Chairman Thayer said legal is known for billing late, so the numbers were likely skewed. Mr. Tougas said that it looked like the costs of foreign pleasure crafts were down and asked Mr. Bay if he had a comparison to the previous year. Chairman Thayer said that they do not do a comparison during the season and, instead, wait to do an annual FPC report at their Fall meeting. With no other questions for Ms. Dumas, the board thanked her for her time.
