## Agenda Item 7 Scope of Practice Issues

A. Board of Medicine Discussion.

Cathy Giessel reported on her discussion with the Board of Medicine at their October 2006 meeting. Chairwoman Giessel spoke with the Board of Medicine about advanced practice nursing. She took questions from Drs. Tomera, Flaming, and Head. Specifically, Dr. Head asked what kind of oversight and assurance is required of ANPs in regards to appropriate referrals? Ms. Giessel referred the members of the Board of Medicine to the regulations that refer to the practice authority for ANPs 12 AAC 44.400(5) and for CRNAs 12 AAC 44.500(4). The Board of Nursing also relies on the ethics and professionalism of the licensees.

After the presentation by Cathy Giessel, Dr. Head stated that he thought the Board of Medicine had enough business "on their plates", regulating physicians, and did not need to take on Advanced Nurse Practitioners.

The Board discussed the need to inform NPs and CRNAs to keep their consultation and referral plans current when they change jobs.

B. Objective Measures for Evaluating Scope of Practice Requests for Registered Nurses or Advanced Nurse Practitioners

Discussion took place regarding the draft of an Objective Measures for Evaluating Scope of Practice Requests for Registered Nurses or Advanced Nurse Practitioners. The topic was deferred to later in the meeting as Director Urion joined the meeting.

#### C. Director's Report.

Director Urion stated that he felt that the Nurse Consultant I position did not need to be filled. The Board pointed out that the Nurse Consultant I position is mandated by Administrative Order #115, signed by Governor Steve Cowper on August 4, 1989. It creates compliance with Omnibus Budget Reconciliation Act

of 1987. (Citations 42 CFR483.75; 42 CFR 483 Subpart D; Secs. 1902 (a)(28) 1919 (f)(2), P.L. 100-203 (Sec. 4211 (a)(3); P.L. 101-239 (Sec. 6901 (b)(3) and (4); P.L. 101-508 (Sec. 4801(a)). Federal Medicaid funding is linked to the Board of Nursing complying with these mandates. In addition, the Board assigns the Nurse Consultant I staff person to develop expertise in Chemical Dependency issues, to more effectively oversee this regulation issue. Director Urion approved posting the position.

Director Urion asked if there were legislative issues to be introduced during the legislative session on behalf of the Board of Nursing. There were no issues identified at this time.

Director Urion approved travel to send two Board members and the Executive Administrator to the mid-year meeting of the National Council of State Boards of Nursing (NCSBN), if the budget will support the travel. He also approved one Board member to attend the annual meeting of the NCSBN. The Executive Administrator's and Board Chair's travel to the annual meeting is funded by NCSBN.

The Board reviewed and discussed the UAA School of Nursing annual report presented by Dr. Jean Ballantyne, Director, and Dr. Jackie Pflaum, Associate Director.

Board members inquired about the survey completed in 2006 finding that there is a low industry demand for LPNs. Dr. Ballantyne stated that the School of Nursing has not formally suspended the LPN program and that a class will begin in January 2007. Prior to suspending the program, they will seek input from the community about resources and may have to concentrate those resources on RN education instead of continuing the LPN program.

Board members also noted a pass rate of 80% on the NCLEX for first time candidates educated in the baccalaureate program. One year might not be a trend, but declining pass rates are of concern. Gail Holtzman, Baccalaureate Nursing Program chair, identified several strategies that have been implemented to increase the pass rate. The response to these changes will not be seen for a couple of years. The faculty of the baccalaureate program is encourage their students to take a NCLEX review course and to not wait until their temporary licenses are close to expiring before taking the exam.

The pass rate of 75% for first time candidates educated in the associate's degree program was addressed by Carol Coose, ADN program chair. The decline in pass rates was partially attributed to offering the program in distance sites (Fairbanks, and other rural sites).

The School of Nursing continues the RRANN program which is focused on success of Alaska Native students, but offers tutoring to all students. In addition, students who speak English as a second language also tend to have difficulty with the nursing programs.

Recruitment and retention of qualified faculty were identified as on-going problems. Dr. Ballantyne stated that nationwide there is a faculty shortage and the market for nursing faculty is very competitive. The UAA School of Nursing has difficulty recruiting because of salaries that are not competitive, the location of the jobs and the cost of housing. The School of Nursing, however, is actively recruiting for several positions.

RESOLVED that the Board of Nursing for the State of Alaska confer on-going approval of University of Alaska School of Nursing Programs.
