Agenda Item 6. Nurse Aide Report

The Board reviewed and discussed the report presented by Lisa Maroney, Licensing Examiner. The report included nurse aide testing results from around the state for December 2006. Ms. Maroney also informed the Board about the Criminal Background Check regulations recently promulgated by the Department of Health and Social Services, which will affect Certified Nurse Aide students training in licensed facilities.

The Board recessed for lunch at 12:37 p.m. The Board reconvened from lunch at 2:00 p.m.

Agenda Item 7. <u>Proposed Regulations Projects</u>

Gayle Horetski, AAG and Jun Maiquis, Regulations Specialist joined the Board.

a. Nutritional supplements

The Board reviewed and revised the draft regulations 12AAC 44.945 and 12 AAC 44.970 submitted by Gayle Horetski and Jun Maiquis at the December 2006 meeting. The Board specifically agreed to exclude compounded substances. The regulations will be re-written and brought back to the Board meeting on Friday for further review.

> b. Healthcare facility RN education program approval The Board reviewed a checklist summarizing information requested for healthcare facilities wishing to offer courses of study for nurses to expand their expertise and scope of practice. It was determined that the checklist was a Board tool and not appropriate for inclusion in regulation.

The Chair proposed the one or two Board members work on standards for Facility Education Program approval checklist. Terri Olson and Beth Farnstrom volunteered to work on the checklist using the real estate Board's guidelines in 12AAC 64.400-470 as a possible template. They will bring revisions to the Board at the June meeting.

c. NCLEX pass rates

At the March 2005 Board meeting, the Board unanimously passed a motion establishing an acceptable NCLEX pass rate for first time test takers. This pass rate would be reviewed on an annual basis for the Alaska education programs, as a measure of the quality of their programs. The Board outlined remediation steps that would be implemented if a program did not meet the annual average 80% pass rate. This was never put into regulation, though the Board recalls requesting this in the past. Mr. Maiquis will begin work on this project. When the regulations are prepared, consideration will be given to adding the Certified Nurse Aide programs to it.

The Board recessed for a break at 3:56 p.m. The Board reconvened from break at 4:04 p.m.

d. Barrier Crimes

The Board reviewed recent barrier crime regulations enacted by Department of Health and Social Services. Ms. Horetski advised the Board that it could also promulgate barrier crime regulations. The Board reviewed similar regulations used in other states and will address this in the future.

 e. In response to a question about saving mail ballots on MOAs, AAG Horetski stated that results should be kept in the licensee's file until they are no longer a licensee.

f. New regulations

The Board reviewed regulations changes proposed by staff.

Agenda Item 9. <u>Licensing Examiner Report</u>

The Board reviewed and discussed the report presented by Abraham Weiss, Licensing Examiner, noting 66% of Registered Nurses renewed online for 2006-2008 and 49% of Licensed Practical Nurses renewed online, both of which are an increase from last relicensure. NCLEX pass rates for the quarter were reviewed. A professional courtesy letter will be sent to AVTEC related to their NCLEX-PN pass rates.

Refresher Course Approval

Nancy Sanders, PhD, RN, Executive Administrator, presented a request from Tamara Williams who took a Registered Nurse Refresher course from Parkland College. This program was online and was not approved by the Board, per AS 08.68.251(b)(1) and 12 AAC 44.600-660. After discussion of the issue,

On a motion duly made by Terri Olson, seconded by JoAnne Bell-Graves, and passed unanimously, the Board

RESOLVED that no exception would be made for Tamara Williams in accepting a non-Board approved Registered Nurse Refresher Course from Parkland College.

Nancy Sanders, PhD, RN, Executive Administrator will communicate with RN Williams. The list of approved Registered Nurse refresher courses will be reviewed and updated for the website.

The Board declined to delegate the approval process for refresher courses to the Executive Administrator.

Agenda Item 13. NCSBN Update

a. Teleconference information: imposters

Nancy Sanders, PhD, RN, Executive Administrator reviewed information from an audioconference with National Council of State Boards of Nursing related to imposters. She will be attempting to find more information to increase the expertise of the licensing examiners for detecting fraudulent applications.

b. APRN Summit report

Cathy Giessel reviewed discussion at that meeting re: NP certification and testing.

c. Mid-Year Meeting

This meeting will be April 2-4, 2007 in New Orleans, attended by Nancy Sanders, PhD, RN, Executive Administrator and Cathy Giessel, Board chair.

d. Annual Meeting

This meeting will be August 7-10, 2007. The National Council of State Boards of Nursing pays for the Board Executive and Chair to attend. Rick Urion, Director, authorized attendance by an additional Board member, paid for by the Board, if the budget allows.

e. Uniform Emergency Providers Act Cathy Giessel shared a summary of this model policy/legislative action to help ensure public safety for the provision of healthcare services in an emergency.

f. Disciplinary Resources Advisory Panel

Cathy Giessel serves on this National Council of State Boards of Nursing committee, which is currently working on a model pain policy guideline for state Boards. There are three areas being researched: pain medication prescribing by NPs, licensees who routinely utilize pain medications and fitness to practice, and the chemically dependent licensee.

At 10:41 a.m., Joanne Smith joined the Board.

Agenda Item 20. Review Goals & Objectives

The Board reviewed, discussed and updated Accomplishments, and Goals.

Agenda Item 8 <u>License applications question review</u>

a. License questions on criminal history

The Board reviewed and discussed the questions on the applications. The goal would be to have uniform questions on all applications and that the questions be clearly understandable to all license applicants.

The Board recessed for lunch at 12:38 p.m. The Board reconvened after lunch at 1:30 p.m.

Agenda Item 10. Budget Update

The Board is joined by Rhonda Leatham, accounting technician II who reviewed the budget and expenditures in detail. The Board had additional requests for data. Ms. Leatham will research the questions and return later in the day with answers.

Agenda Item 11. Practice Issues

a. Anesthesia advisory

The Board received a letter from Christine Anderson, RN, Director of Patient Care Services at South Peninsula Hospital. Anderson questioned the need for an LIP to be immediately available after an intubated patient is stabilized but still receiving anesthetic agents to allow them to be effectively and safely ventilated.

On a motion duly made by Jim Jurrens, seconded by JoAnne Bell-Graves, and passed unanimously,

RESOLVED that the Board adopts a change in the Advisory Opinion for Nurse Administration of Sedating and Anesthetic Agents in II. D. to read

- **D. Patient Monitoring**
- 1. Patient monitoring will be established by facility policy and specified by patient need.
- 2. The requirement in II. B. 3. is not required for the stabilized, intubated patient.

Kitty Wellmann, MS, RN, PNP, FNP, Advanced Nurse Practitioner, was on audio conference to discuss an email she sent to the Board, expressing concern about the prohibition on RN administration of anesthetic agents for anxiolysis. NP Wellmann also felt that the prohibition on nurse administration to patients with ASA scores of III or IV was too restrictive. She also asked the Board to consider recent changes to ACLS & PALS regarding bagging for resuscitation. After discussion, the Board wished to invite broader input. This will be scheduled on the June Board agenda. The Board will act on NP Wellmann's suggestion that the consistent term, "procedural sedation" be used in the Advisory Opinion instead of "moderate sedation".

- b. Checklist for individual RN/ANP scope of practice questions The Board reviewed the document developed at the December 2006 Board meeting. Edits were made. Nancy Sanders, PhD, RN, Executive Administrator will do further formatting and edits, and present to the Board at the June meeting.
- c. LPN IV push medications

Dr. Leo Bustad, MD, with the Alaska Heart Institute was on audioconference to request review of Licensed Practical Nurse scope of practice. He asked if it is within the scope of practice for a Licensed Practical Nurse to administer premixed IV solutions of medications such as dobutamine and adenosine, via infusion pump. He states that the Licensed Practical Nurse is appropriately trained and that the setting provides appropriate resuscitation equipment, as well as NPs and cardiologists who are immediately available.

The Board stated that a Licensed Practical Nurse, who is appropriately trained, would be within their scope of practice to administer pre-mixed medications via infusion pump in this setting.

d. Delegation of Controlled Substances administration to UAP
The Board reviewed an email from Karen McLane, an NP working in Nome, who wished clarification concerning her ability to delegate administration of IM Morphine and Demerol, as well as administration of oral Tylenol #3 to Community Health Aides in remote areas. The Board reviewed 12 AAC 965 (e) and 12 AAC 44.970 (10) and (13), concluding that this would not be delegatable. Nancy Sanders, PhD, RN, Executive Administrator will communicate with NP McLane.

e. Laryngeal mask use

Chris Glaspell, RN at Fairbanks Memorial Hospital asked whether trained Registered Nurses are within their scope of practice to insert laryngeal mask airways. The Board concluded that this is within the scope of practice of a trained RN. Nancy Sanders, PhD, RN, Executive Administrator will communicate this to RN Galspell.

The Board recesses for a break at 3:39 p.m. The Board reconvenes from the break at 3:54 p.m.

Agenda Item 10. Budget Update

The Board is rejoined by Rhonda Leatham, accounting technician II, and Jenny Strickler, Chief, Division of Corporations, Business and Professional Licensing. Additional revenue data was reviewed. The Board is concerned that the Board income has been decreasing over the past six years, yet the number of licensees has been increasing. The licensure fees have not changed since 2000.

The Board requested that Chief Strickler research this and prepare an explanation and review of our budget for the June 2007 Board meeting.

a. Correspondence received

The Board reviewed various letters received. One letter from Susan Schafer, Registered Nurse, presented a letter and 30 signatures of nurses which expressed concern that licensees' addresses were public information on the website. Jenny Strickler informed the Board that there is a lawsuit related to this issue and that the Division is awaiting the decision of the court.

UAA School of Nursing reported to the Board that only Licensed Practical Nurse preceptors are used for PN students. In addition, UAA will be suspending admissions for PN students after the 2007 cohort.

Therefore, the Alaska Board of Nursing recognizes the professional responsibility of nurses to accept or decline overtime assignments based on their self-assessment of ability to provide safe care."

d. Department of Health and Social Services regulation project for 7 AAC 12.415(b) and (c) would potentially put in place a collaborative oversight requirement for Certified Nurse Midwifes. The Board directed Cathy Giessel to submit written comment opposing this.
