- LPN Scope of Practice is pending review with Law- it might need another resource, as well as further review.
 - Recommends the Board reconsiders/reviews scope of practice advisory opinion that is used and referenced for outlining standards for LPNs.
 - o The other option is for a lawyer to review it.
- Preliminary review by Dept. of Law completed today:
 - o 12 AAC 44.320 (h) a temporary nonrenewal permit available
 - o 12 AAC 44.740(c) changes made for clarification, broken down
 - Urged to include self-reporting as part of the requirement in the regulation
 - Discussing regulatory term vs medical term of "habitual use of alcohol"
 - Discussing concept of having to ask someone to admit to a diagnosis they have not yet obtained
 - Possibility that it might not be illegal use of a substance- It could be a substance that is being prescribed (and then turns into a disorder)
 - New wording will go back to Law for approval
 - o 12 AAC 44.740 Heading Add in "And Alternative Probation" to header
 - o 12 AAC 44.317 (a)- Nursing is the only license type to not allow renewal after lapsing
 - Changes to allow renewal if lapsed for less than 60 days
 - Division is moving away from requiring notarized signature pages
