I was subsequently charged with Misconduct Involving a Controlled Substance in the Fourth Degree (Class C Felony) and Theft in the Fourth Degree (less than \$250) (Class B Misdemeanor), under Alaska Court Case # 3AN15-11290CR. On February 25, 2016, after a Change of Plea, I was convicted one (1) count of Theft in the Fourth Degree (less than \$250) (Class B Misdemeanor) for the theft of the Hydrocodone tablets.

I acknowledge the above action provide grounds for suspension, revocation or other disciplinary sanctions of my license pursuant to Alaska Statute (AS) 08.01.075, AS 08.80.261(a)(2), (a)(11) and 12 AAC 52.920(a)(4).

I understand that as a result of this license surrender, I cannot practice as Pharmacy Technician in the State of Alaska, and will not be able to do so until I have the approval of the Board. I further understand that before my license to practice as a Pharmacy Technician in Alaska can be reinstated, I will have to demonstrate to the Board that I am competent to resume practice, and am able to do so with skill and safety. If I make such request for reinstatement, and the Board denies me, I have the right to a Hearing, pursuant to AS 44.62, of the Administrative Procedure Act.
