### **VOLUNTARY SUSPENSION OF LICENSE**

I, Cynthia Aguiar, Pharmacist, voluntarily agree to suspend my Alaska Pharmacist license # PHAP1602, which was first issued to me on August 15, 2005 and will lapse, unless renewed, on June 30, 2018.

I am agreeing to the voluntary suspension of my license at this time with the understanding that the Division of Corporations, Business and Professional Licensing (Division), on behalf of the Alaska Board of Pharmacy (Board), is investigating my self-report of depression and substance abuse and subsequent clinical assessment provided by my health care provider of alcohol dependence, opioid dependence and recurrent major depressive disorder (as documented within CBPL Case #2017-000092).

I understand that my Alaska license will remain suspended and I agree to stop practicing until the Division has completed the investigation and the Board has reviewed the findings of the investigation and is convinced I can return to practice with skill and safety. I understand that during the period my Alaska license is suspended I must remain in compliance with all licensing requirements as required under AS 08.80. If I make a request to vacate the suspension of my license and the Board denies me, I have the right to a hearing pursuant to AS 44.62 of the Administrative Procedures Act (APA).

I am agreeing to the voluntary suspension of my pharmacist license of my own free will. I am not under the influence of any medicine or other drugs that would affect my ability to think clearly and rationally. No promises or threats have been made to me by anyone to make me sign this document.
