No movement since last meeting on HB137/SB74; HB85/SB83; HB314/SB225. Continue to monitor.

HB336 - Athletic Trainers Scope of Practice referred to House Labor + Commerce 4/17/2024. Bill sponsor promised to work on language changes with state association. PHY Letter of Opposition on file. No other letters of support or opposition filed by state association or other boards as of this date. Continue to monitor bill advancement.

SB91 - Telehealth: MultiDisciplinary Care Team - Deputy Director provided requested information. "not reasonably available in the state" is not defined. Concern while intent/use may be narrow via telehealth, bill language does open door for readily available ongoing care for by out-of-state licensed therapists who are members of a physician's team for telehealth without an AK license in non-emergent situations. Concern this bill would bypass PT/OT compact bill (telehealth situation only). Concern with who/how disciplinary actions will be handled for non-AK licensed therapists who provide care for AK patients. Need clarification of how complaints will be handled/adjudicated in 08.02.140. Who is the "department"? Who interprets scope? Does the PHY board budget get charged for any related investigations?

HB115 - Naturopaths; Licensing; Practice - Support naturopaths implementing their own board; concerned that scope is too broad. Enlow Walker to draft letter with concerns for board review/vote.

  - Where do costs of investigations get attributed to - budget for each board of multidisciplinary team profession type or department budget?
- HB187 - Prior Auth Exempt for Health Providers - Letter of Support on file. No testimony necessary . Continue to monitor.
- HB115 - Naturopaths; Licensing; Practice - Enlow Walker to draft letter with concerns by end of business 04/26/2024 for Board to review/vote.
