 - Not within the board's purview to solicit on behalf of others.
 Cannot endorse projects don't have enough understanding of project/facts of submission. Board's duty is public protection and licensing.
 - State makes some licensee information public and available.
 Ability to contact directly without going through the board.
 - Staff to compose draft and put in OnBoard for full board review and approval.
 - OT Scope of Practice Pelvic Floor Training 06-19-2024
 - CE approval portion of question was previously answered by licensing examiner. Board to answer "Is pelvic floor training within occupational therapist scope of practice and can it count as CE?"

 - Extensive discussion regarding 12 AAC 54.530 Standards for Practice of Telerehabilitation by Physical Therapists and the specific passage [to provide physical therapy to patients who are located in this state and do not have access to a physical therapist in person due to "geographic constraints or health and safety constraints"] Department of Law to review draft letter.
 - PTA as Director of Rehabilitation 06-14-2024
 - Can a PTA be a Director of Rehab in a long term care facility? AK PT/OT practice act does not prohibit PTA from being employed as a Director of Rehab. Anyone can be Director of Rehab does not have to be licensed individual administrative duty. Problem arises because PTA still subject to supervision by licensed PT. PTA serving as director does not increase their scope of practice or ability to perform services outside their scope of practice.

Health/safety constraints do not exist as patient in long term care facility. Questions exist such as in-house staffing availability of PT/PTA. Sheri to forward DRAFT to Department of Law for review.
