Agenda Item 5

Review 08.88.221 and 08.88.450

Ms. Walsh discussed with the Commission an e-mail response from Don Habeger, Director of Corporation, Business and Professional Licensing, in regards to statutes 08.88.221 and 08.88.450. Ms. Walsh stated that her predecessors all had this fee going into the Recovery Fund (ZSU) and that prior audits did not indicate that this fee was miscoded/misdirected into the Recovery Fund (Surety Fund) and should have gone into REC. Ms. Walsh stated that Laura Watson, Accounting Technician IV had a discussion with Sara Chambers, Program Coordinator with Corporation, Business and Professional Licensing and asked to change the forms for courses and instructor from ZSU to REC because the Commission does not have the authority based on 08.88.221 to be collecting these fees. Ms. Davis stated that this is scary because that is taking money out that needs to go into the Recovery Fund. Ms. Burke stated that the licensees are absorbing many costs that are not appropriate but this is a part of the licensee's responsibility as their function of helping to regulate the industry. The Department of Commerce, Community, and Economic Development shall set fees under AS 08.88.065 for a real estate broker, associate broker, or salesperson. There isn't anything saying about the money going into REC or to the General Account. This has gone through Legislative Audit examinations, three different administrative directors, and many different people on the Commission and this issue has never been raised. Another point that is important is that the Commission should consider the Recovery Fund is not a governmental entity, it is a trust, in which the Commission members are trustees for this money. The Legislature has been quite clear on what this money should be used for and what our responsibilities are as to making sure we maintain a certain balance. Ms. Burke suggested that legislation should be introduced as soon as possible to clarify the number of these issues that are coming up and will continue to come up. If we do not get these clarifications in at the beginning of this session there is going to be a lot of other things that people will feel that are more important and it will not get high priority. We need the industry to lobby for the priority of these issues. Ms. Bates stated that she will communicate with David Somers, Somers and Associates Realtors, Inc to ask for their assistance to put something together. Mr. Cole stated that the Commission and REC staff will follow the statutes and regulations that are mandated for anything that is done but in this particular case it is unacceptable that they would ask the Commission to make an administrative change for a form to designate where this money is going to.

On a motion duly made by Ms. Burke seconded by Ms. Bates, it was,

RESOLVED to adjourn the meeting.
