#### **Needs**

Statutory Changes- Board will likely pursue statutory authority to regulate Animal Euthanasia Permits as well as conforming changes to regulations.

Statutory Change- AS 08.98.180 the word "exams" needs to be updated to the singular "exam."

Statutory Change- AS 08.98.180- clarifying language needs to be updated to reflect that temporary licenses are not valid once results of NAVLE exam are published.

Regulatory Change- Board will be looking at regulations putting forth requirements for medical record keeping, regulations regarding emergency availability of veterinarians, regulations regarding definition of "medical" with regards to continuing education.

Board Vacancies- The Board currently has 3 seats available – 1 has remained vacant for XXX years, 1 veterinary seat termed out in March 2024 (that member will continue to serve until seat is filled), and 1 public member seat that termed out in March 2024 (that member will continue to serve until seat is filled).

Travel approval for 1 in-person Board meeting so as to provide opportunity to engage licensees, members of the public, or legislators as necessary.

Travel approval for 2 members to attend the annual AAVSB meeting.
