# **Certification of Completed Trainee Training**

## for Body Piercing in Alaska

Upon completion of a course of training under this section, the trainer shall submit a certificate of trainee training form <u>no later than</u> <u>30 days after the completion of training</u>, documenting the theory hours and practical operations. **Please return the completed form directly to the Alaska Board of Barbers and Hairdressers at the letterhead address.** 

12 AAC 09.167 requires a trainee who is receiving training in body piercing to complete a curriculum that consists of at least 1,000 hours of theoretical and practical training. The training must include a minimum of 270 hours of theory instruction in specific subjects and a minimum of 150 practical operations. The remaining hours may be obtained in theory hours, practical hours, or a combination of both.
