12 AAC 09.168 requires a student who is receiving training in permanent cosmetic coloring must complete a curriculum that consists of at least 250 hours of training. The training must include a minimum of 125 hours of theory instruction and a minimum of 75 hours of practical operations. The remaining hours may be obtained through a combination of theory hours and practical operations or just practical operations.
