Permit to Euthanize Domestic Animals Renewal

July 1, 2023 – June 30, 2025

- Your permit lapses after June 30, 2023. There is no grace period — it is illegal to work if your permit has lapsed.
Emailed applications will not be accepted.
Make checks and money orders payable to the State of Alaska or use the attached credit card payment form.
Plan on a 4–6-week processing time for correct and complete renewal applications.
Once the renewal is processed, your license certificate will be available for printing via the MY LICENSE self-service portal.
