



**Alaska Alcoholic Beverage Control Board**

**Alcoholic Beverage Auction Permit Application**

**Eligible Entities:** Per AS 04.09.660, only **nonprofits**, i.e., fraternal, civic, professional, or patriotic organization, that is incorporated under AS 10.20 and has been active for a period of at least two years before filing an application. The application under AS 04.11.260 must be signed by two officers of the organization.

**Permit Fee:** \$50 per day.

**Event Requirements:** The director may issue a permit only for designated premises for a specific event and for a limited period as specified in the application.

**Permit Restrictions:** All profits derived from the sale of alcoholic beverages under the alcoholic beverage auction permit are paid go to the organization that holds the permit and not to the individual. No more than five alcohol beverage auction permits may be granted in a calendar year.

I declare that all of the information contained herein, and evidence or other documents submitted are true and correct. I understand that any falsification or misrepresentation of any item or response in this application, or any attachment, or documents to support this application, is sufficient grounds for denying or revoking a license/permit. I further understand that it is a Class A misdemeanor under Alaska Statute 11.56.210 to falsify an application and commit the crime of unsworn falsification.
