



Alaska Alcoholic Beverage Control Board Art Exhibit Permit Application

Eligible License Types: Beverage Dispensary License (BDL), Beverage Dispensary – Tourism; Restaurant or Eating Place (REPL) and Seasonal Restaurant or Eating Place – Tourism (SRTL).

Permit Fee: \$100 first 2 days, \$50 each additional day.

Event Requirements: an art exhibit permit to sell and serve brewed beverages or wine for consumption at a specific art exhibit event as described under AS 04.09.640. Food must be provided in conjunction with the service of brewed beverages and wine. Brewed beverages and wine may not be transported between specified sites. An "art exhibit event" or "event" means a public event involving an art display or similar activity approved by the board that is held for a limited period at one or more art galleries, art studios, art stores, art dealer stores, or museums.

Permit Restrictions: This permit may not be exercised during an event that is expected to attract attendees under 21 years of age. Only brewed beverages and wine may be served. No more than 12 permits may be granted in a calendar year.

Additional documents required: Menu of food to be provided.
