## Alaska Alcoholic Beverage Control Board Manufacturer Retailer Live Music or Entertainment Permit Application

**Eligible License Types:** brewery retail, distillery retail, or winery retail license.

Permit Fee: \$100 per event.

**Event Requirements:** A manufacturer retailer live music or entertainment permit authorizes the holder of a brewery retail license, winery retail license, or distillery retail license to allow live music or other entertainment on the licensed premises where consumption occurs. The director may issue a music festival permit only for designated premises for a specific occasion and for a limited period during a single day between the hours of 9:00 a.m. and 9:00 p.m., as set forth in AS 04.09.685 and 3 AAC 305.380. **Permit Restrictions:** The director may not issue more than four permits to a licensee in a calendar year.
