Dear J. Hamilton,

Millicent Peabody sold her 6.5% of ownership in Turkey Red LLC. I purchased a majority of her shares as did Ellen VandeVisse, who has been a member of the LLC since the beginning in 2007. That purchase increased my shares from 51% to 52% and Ellen's from 9.5% to 10.5%. This was the first time a member of the LLC sold their shares, so I apologize for not sending in the correct information. I did correct it with the Division of Corporations, Business & Professional Licensing in 2018. I have attached a copy to this reply of ownership in 2017 and the 2018 changes.

Ellen VandeVisse is out of State until mid November. I have all forms ready for her to fill out including instructions for a background check and fingerprinting now that she owns over 10%.

I have been the only majority Member. No other Member has owned 10% or more until Ellen VandeVisse purchased some of Millicent Peabody's shares. The change was less than 10% of total shares. If another member increases their shares to 10% or over, or 10% or more of shares are exchanged, a change of ownership report will be sent to the Board in writing in duplicate within 10 days of the change.

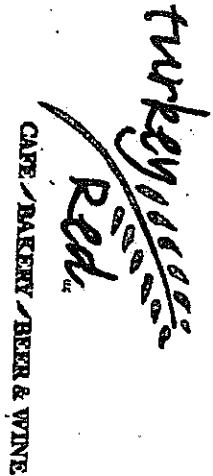

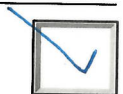
