



Land's End Outdoor Deck Security Plan:

The Land's End outdoor deck is an extension of our restaurant via two doorways during warm sunny days- it is not open all the time, and is only open for service upon the restaurant manager's approval. The deck has a 40 inch wooden railing around it that separates and secures the area from the beach. Additionally, the deck is 3 to 4 feet higher than the beach, and this height adds an additional barrier to secure the area. The whole deck is visible from indoors via the length of windows along the restaurant wall.

The same personnel manage and serve, and the same practices are exercised, as in the indoor licensed area.
