Security plan for golf course

The golf course is enclosed with 8 ft. high chain link fencing and is regularly monitored and patrolled by course marshals. All product is served by TAPs certified snack shop attendants, and beverage cart drivers who are trained in proper service of alcohol to include checking ID's and monitoring consumption. The beverage cart has locked compartments and is accompanied by a licensed beverage cart driver.
