Mr. Belt said he knew the rules but it slipped his mind. Ms. Martin said it was her belief that after being signed in, non-members could pay for their drinks. Contact was made with Manager Laurie Almquist and AMVETS Post #33, Manager Diana Estrada, where Ms. Martin also works. Ms. Almquist said Ms. Martin was provided training not to allow non-club members. Ms. Estrada said basically the same but on several occasions, has caught Ms. Martin failing to check membership cards. Ms. Martin was issued a citation for Sales to a non-club member with an optional court appearance.

The bar staff has now been trained on the proper procedure for non member admittance into Never Forget Amvets post 11 as follows:
(These rule are being added to the employee handbook that is currently being revised)

All non members have to be signed in by a current/in good standing member.
Non member is not allowed to purchase any beverage item. Any beverage they order is to be paid by a member in good standing only.

I am not sure why our club business was discussed with another Veterans organization, even if Ms. Martin works there. As this being a legal matter it seems that Ms. Martins citation at one organization (Amvets) should not have been discussed with another organization (American Legion).

Based on my understanding, the AMOC is responsible for the training/standards for which servers have to adhere to, I would like to state that in the materials/training that is taught currently, I personal have not seen the additional rules for Veterans/Membership clubs addressed. It would be my hope that if nothing else is taught on these additional rules, that at least a pamphlet be given in the training to make servers aware of the additional guidelines for these organizations.





As indicated in the Notice of Violation dated April 19, 2024, an inspection was completed at the Brown Jug located at 525 W Fireweed Lane Anchorage, Alaska, Alcohol License #395. During this inspection the Manager, Mr. Mark Landon, provided his valid food handler's permit but not a valid alcohol server's card. The Notice of Violation has requested a response from Liquor Stores USA North Inc. (LSUN) outlining action taken to prevent a reoccurrence of this violation.

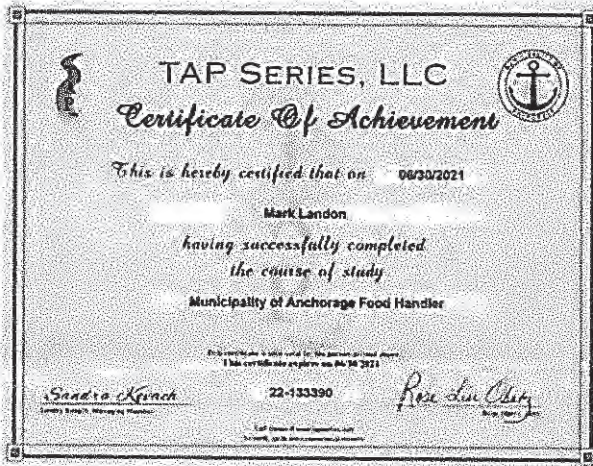
LSUN takes this violation very seriously, as demonstrated by the company's long history of compliance with ABC Board regulations, and a commitment to being a responsible retailer in the communities where LSUN operates. Outlined below is a brief overview of LSUN's onboarding process for new employees and the additional step added to prevent a reoccurrence of this violation.

Training for Alcohol Professionals (Taps) certification verification for new employees is as follows:

1. Area Manager(s) perform initial verification of Taps cards as part of the hiring process. If an applicant does not have a Taps card, the applicant is not set up for on-boarding until passing a Taps class and providing the card for verification.
2. Area Manager(s) then send employee documents (Taps, I-9) to the Human Resources department for secondary review and processing and to set up the new employee in ADP (LSUN's personnel management software).
3. Since receiving this Notice of Violation, LSUN has implemented a supplementary compliance measure. The LSUN Training Manager (by way of store audits) will verify all Taps cards and employee IDs monthly.

While there is no excuse for this oversight and additional verification has been added to LSUN's internal processes, LSUN believes the reason for the verification process error is based

on the similar terms used in the permits. Of specific note is the reference at the top of the food handler's permit to "Tap Series", causing some confusion. Both permits are pictured below.



As also indicated by the picture, Mr. Landon promptly completed his TAP certification with CHARR the day after the inspection was conducted, taking steps to immediately correct this error, and becoming compliant. Liquor Stores USA North Inc. understands the serious nature of this violation and is confident the process adjustment will remedy any systemic issues hindering compliance.

Dear Alcoholic Beverage Control Board,

On behalf of Jimmy Sushi Restaurant, I sincerely apologize for the issues identified during the inspections on May 6th and May 10th. We recognize that due to lax oversight, our employee, Mr. Jianmin Cen, mistakenly served alcohol without a server's permit, reflecting our oversight in management. Additionally, another employee, Ms. Vivilian Lee, had an expired server card, which also highlights our negligence in updating employee permits.

Since the incident, we have implemented the following measures to ensure such incidents do not recur:

1. We have arranged for all new employees and those needing renewal to take the server's permit exam, ensuring they do not handle alcohol sales until certified.

We currently operate with two morning servers Gerardo Ramos and Obreyel Myers. Officer Joe Linger came in and requested to speak with management. Sunny Murguia came downstairs to assist in his request. He requested to see both Sunny Murguia and Obreyel Myers Taps cards, both had unfortunately expired on April 27 th, 2024. Gerardo Ramos taps card is current. I understand that is not acceptable, however, I am writing this letter to request that you possibly have some leniency in this matter. We truly have a series of unfortunate events that transpired in the prior weeks before to your visit. I would like to shed some light on and have attached some documented proofs in the matters that follow:

On April 22, 2024, our server Obreyel Myers home caught fire leaving her and her 3 young children homeless. She requested to still work and pick up her morning shifts, but we have been trying to help navigate knowing some days she may have to call out. That's why we have Gerardo Ramos constantly available due to short staffing issues.

All our other servers have current updated Taps cards, and we are compliant with all regulations. Gerardo Ramos card was in his wallet which was lost at his sons soccer practice the night before. We attached proof that a nice man contacted gerardo that night but gerardo was unaware of the message until 05/07/24 that night.

Sunny Murguia isn't required to have a Taps card as she is working in the office and not serving, she just had it for an event that was held prior back in 2021. Obyeral Myers is now current and tap card is attached. We plan to have a dedicated folder for all taps card for easy access and a reminder on Gerardo calender for all upcoming expiration dates of taps card for his employees.

I understand now Officer Linger arrived we seemed not compliant. but it truly was an off day to say the least. If you can consider our request, we would be very grateful. Thank you for your time and understanding.

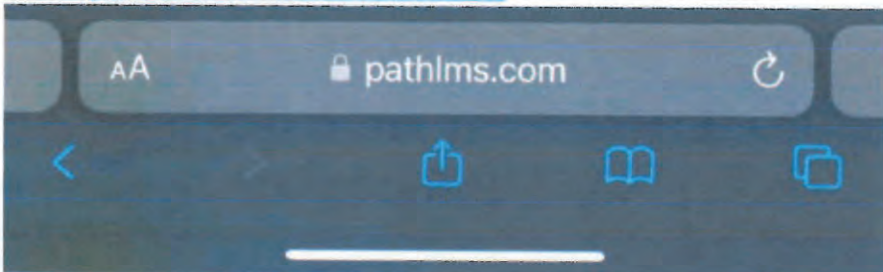




