

This is a notice to you as licensee that an alleged violation has occurred. If the Alcoholic Beverage Control Board decides to ac against your license, under the provisions of AS 44.62.330 - AS 44.62.630 (Administrative Procedures Act) you will receive an Accusation and Notice of your right to an Administrative Hearing.

#### Note: This is not an accusation or a criminal complaint.

On 1-3-23, an inspection was conducted at your establishment. Server Leonardo Crez-Reiz was asked to provide proof of current alcohol server education. Mr. Crez-Reiz could not provide proof. He was told to stop serving alcoholic beverages until he could provide proof of current alcohol server education to the Board. Later, Inv. Hamiton contacted CHARR and learned that had taken a server course with them and received certificate 164286, which expired on 6-19-21.

Your attention is directed to AS 04.21.025: Alcohol server education, AS 04.21.030: Responsibility of licensees, agents, and employees, AS 04.16.150: Licensee responsible for violations, and Anchorage Municipal Code 10.50.015(s) which reads, "For a licensee to employ in the licensed business in any capacity which involves the sale or dispensing of alcoholic beverages to the public, any person who has not, prior to the commencement of employment, successfully completed a liquor server awareness training program approved by the state alcoholic beverage control board as provided by sections 2.30.125.B and 10.50.035.B.6."
