This is a notice to you as licensee that an alleged violation has occurred. If the Alcoholic Beverage Control Board decides to act against your license, under the provisions of AS 44.62.330 - AS 44.62.630 (Administrative Procedures Act) you will receive an Accusation and Notice of your right to an Administrative Hearing.

**Note: This is not an accusation or a criminal complaint.**

An inspection was conducted on 7-11-24. The hours of operation posted to the door were from 0730 hours to 2000 hours. In talking with two separate employees, it was confirmed that alcohol sales are being made from 0730 to 0800 hours. Contact was made with management who agreed to change the store hours to 0800 hours.
