This is a notice to you as licensee that an alleged violation has occurred. If the Alcoholic Beverage Control Board decides to act against your license, under the provisions of AS 44.62.330 - AS 44.62.630 (Administrative Procedures Act) you will receive an Accusation and Notice of your right to an Administrative Hearing.

Note: This is not an accusation or a criminal complaint.

On 4-21-23, an inspection was conducted at your establishment. Licensee Cheryl James was asked to provide me with her alcohol server education card. Ms. James could not locate her card but did say she had attended a TAP's course and she believed her card would expire this month or next. She was told to stop selling alcoholic beverages until she provided the Alcoholic Beverage Control Board proof of current training. On 4-24-23, I contacted CHARR and learned that her TAP card had expired 5-15-28.

Your attention is directed to AS 04.21.025, Alcohol server education course, 3AAC 304.465: Alcohol server education course, AS 04.21.030: Responsibility of licensees, agents, and employees, AS 04.16.150: Licensee responsible for violations.

You are directed to respond in writing to this Notice of Violation within 10 days of receipt to explain what action you have taken to prevent a re-occurrence of this violation. FAILURE TO RESPOND TO THIS NOTICE OF VIOLATION WITHIN 10 DAYS WILL RESULT IN YOUR APPEARANCE, EITHER IN PERSON OR TELEPHONICALLY, BEFORE THE ABC BOARD AT THEIR NEXT REGULARLY SCHEDULED BOARD MEETING.
