*Dana W. brings to the Board's attention that a member of the public had a desire to make public comment on a renewal in the delegated consent agenda. Dana W. opens public comment so that the member of the public may speak.*

*Tonja B. raises her hand to speak in person to the delegated consent agenda. She introduces herself as the owner and operator of the Tangle Lakes Lodge. She speaks to license 1117 located a couple miles away from her establishment that was up for renewal in the delegated consent agenda. She comments that the license hasn't been operated in 5 years. She states that she is objecting to the renewal of license 1117.*

*Jane S. provides clarification by saying that license 1117 is in an unincorporated area, there is no local government. So, license 1117 is holding up the spot to apply for a license because Tonja B. has a location that is within 2 miles of where license 1117 is located. Because the businesses are within 5 miles of one another, Tonja B. is unable to apply for that license.*

*Sonya I. explains that license 1117 is also on Tab 74 requesting a time extension due to the death of a sole proprietor and the personal representative has requested more time in order to submit a transfer application.*

*Kevin H. reads aloud AS 04.11.470 which says that there could be a hearing. There would need to be reasons for the objection, put into writing, filed with the board, served to the licensee or personal representative and then the hearing could take place.*

*Dana W. thanks Tonja B. for her testimony and suggest that this be discussed further at Tab 74. He goes on to ask if there are any other members of the public that wish to speak on the topic of those licenses that re in the delegated consent agenda.*
