





Basecamp The Landing AK LLC Outside Security Plan

Basecamp, The Landing AK, LLC d.b.a. The Landing Hotel, Restaurant & Pub/Jeremiah's Pub is located at 3434 Tongass Avenue, Ketchikan, Alaska 99901 The outside deck of the premises is on the second floor of the building and only access way is through the 2 doors coming from the pub. The area is enclosed as part of the building and has metal rails.

Service for this deck will be through the dining area only which will be monitored by staff.

There will be a manager on site at all times, and when the outdoor serving area is open (weather and staffing dependent), there will be waiting staff walking between the indoor seating area, and outdoor area to monitor alcohol consumption. When the indoor seating area is open and the outdoor seating area is closed, doors to the outdoor seating area will be closed and used only for emergency egress. " Per Jon Hooke's conversation with Kristina Serezhenkov on January 17th, we do not yet have a DBA on our business license. We will move forward with adding the DBA to our business license in coming weeks. This will be marked a delegated item, and per Kristina, should not prevent us from being part of the February 4th board meeting agenda."

Re: #6, See my responses to Kristina's questions inline below. Also, if your firm is able to improve the red-line drawings, that would be greatly appreciated. Mine are admittedly not good, but I hope they are helpful!

For the transfer of license application and for both the restaurant endorsement and hotel/motel endorsement application, submit additional diagrams and I need an aerial overview of the hotel. I need a diagram of the entirety of each floor with the proposed premises area(s) outlined in red and labelled.

Per Jon Hooke's conversation with Kristina Serezhenkov on January 17th, we are not trying to license the entire hotel premises. We would like to have the option to provide room service, including the service of liquor in rooms throughout the hotel. That being said, I have attached a drawing of an aerial overview of the entire hotel, but only Jeremiah's Pub (2nd floor) and Sunny Point (4th floor) are outlined in red. Please note that room numbers beginning with 1 are on the 1st floor, those beginning with 2 are on the 2nd floor, those beginning with 3 are on the 3rd floor, and those beginning with 4 are on the 4th floor. The diagram doesn't show Sunny Point, as it shows the rooms that lie below it on the 3rd floor. But I have outlined Sunny Point's location in red, and have also attached a separate drawing of Sunny Point specifically.

Is the main service area on the first floor? I can't understand what I am looking at. Is this the main lobby of your hotel and you wish for the entire lobby to be licensed or is this just the restaurant service area? I need more information and clearly labelled diagrams.

The main service area is in Jeremiah's Pub, which is the red outlined area in the attached drawing, and sits on the 2nd floor. We are not trying to license the main lobby; just Jeremiah's and Sunny Point. Please see the Jeremiah's Diagram as well as the Sunny Point diagram for clearly mapped premises that we intend to license. Please see the Hotel Drawing to understand where those spaces are in relation to the rest of the property.

You mention a 2nd floor deck in your security plan, but I also see an area labelled 'outside patio'. If both areas are outside, then they both need to be addressed in the security plan. I am sending the premises diagrams back to you for reference.

The outside patio referenced in the drawing is the 2nd floor deck mentioned in our security plan. They are one and the same.
