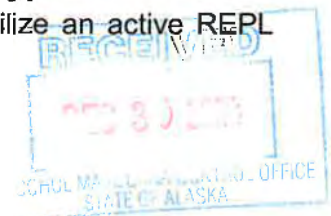
Dear Alcoholic Beverage Control Board Members,

The Kodiak Island Borough (KIB) Assembly formally protests the continued operation of Restaurant Eating Place License (REPL) #2611, held by Sizzler Burger/Peking Restaurant, and respectfully requests the revocation of this license for the second year of its biennial license period. This request is based on the findings of the Clerk's Office investigation, which are outlined below:

- Both the Building Official and the Assessing Director have objected to the continued use and operation of this license, as the business is no longer operating at the licensed address.
- On September 6, 2024, the KIB Assembly submitted a letter to the ABC Board requesting the revocation of this license. The reasons for this request are stated in the letter.
- On October 24, 2024, the City of Kodiak submitted a letter protesting the continued use and operation of this license. The reasons for their objection are outlined in the letter.

Given these findings, the KIB Assembly respectfully requests that the ABC Board revoke Restaurant Eating Place License #2611, held by Sizzler Burger/Peking Restaurant. The license is currently listed as "temporarily surrendered" due to the loss of its operational location. Kodiak has only four available REPL licenses, with the current licensee holding two, neither of which are active. These licenses have been inactive for several years, which has posed challenges to the economic development of Kodiak.

Other businesses in Kodiak are eager to obtain REPL licenses to support their operations. However, License #2611, one of the two held by the licensee, remains unused. The KIB is committed to fostering economic growth in our community, and we strongly advocate for the revocation of this license to allow other businesses the opportunity to utilize an active REPL license.

Dear Alcoholic Beverage Control Board Members,

The Kodiak Island Borough Assembly asks the Alcoholic Beverage Control (ABC) Board to revoke the Restaurant and Eating Place License (REPL) #2611 held by Sizzler Burger and Peking Restaurant. During the Borough Assembly hearing regarding this license, the licensee said she planned to reopen her business, and also said that she was in the process of finding a new location. However, subsequent information has revealed that rather than pursuing the reopening of her business, she is now looking to sell her license.

License #2611 is currently designated as "temporarily surrendered" due to the loss of its operational location. In Kodiak, there are only four REPL licenses available, with the current licensee possessing two, neither of which are active. In fact, these licenses have been inactive for years, presenting somewhat of a challenge to the economic development of Kodiak. There are other Kodiak businesses eager to obtain REPL licenses to enhance their operations; however, license #2611, one of the two held by the licensee, remains unused. The Kodiak Island Borough is committed to fostering economic growth and, therefore, we strongly advocate for the revocation of license #2611 to allow other businesses the opportunity to utilize the REPL license.

To: The Alcoholic Beverage Control Board,

The Kodiak City Council is lodging a protest with the Alcoholic Beverage Control Board for the continued use and operation of the Sizzler Burger & Peking Restaurant REPL License No. 2611. The City Council had limited documentation and lacked familiarity with Alcohol and Marijuana Control Office processes within the initial 60-day protest period set by AMCO. The City Council held a public hearing on October 10, 2024, following the postponement of the action from the July 25 and August 8, 2024, regular meetings. Stephanie Kim spoke during the meeting on August 8, 2024, to inform the Council of the challenges to re-open Sizzler Burger & Peking Restaurant.

Upon further review of the renewal application submitted by Sizzler Burger & Peking Restaurant dated December 26, 2023, the restaurant's application for renewal as stated in their forms AB-17 and AB-33 includes data for food and alcohol revenue generated in 2022 and 2023. The restaurant had originally filed \$0 on City sales tax returns for 2023. It is our understanding the City can protest the second year of continued operations pursuant to AS 04.11.480. Please accept this protest due to inconsistencies filed in their application while remitting taxes and inability to provide restaurant and eating place services while holding this license. The City of Kodiak further protests this license on the grounds that the Building Official indicated the physical location of 116 W Rezanof Dr. is a vacant building and that it was renovated without the permits required by Kodiak City Code, and the Fire Marshall indicated the building is not compliant with fire inspection requirements.

A public hearing was held on this protest on October 24, 2024, during the City Council regular meeting at 6:30 p.m. in the Kodiak Public Library. Ms. Kim was notified of the meeting and her opportunity to participate.

REPL No. 2611 is currently designated as "active-temporarily surrendered" as a result of the loss of its operational location. It is well known that the restaurant has not operated for several years, including the years referenced in the application; therefore, we request enforcement investigate the validity of this application.

Kodiak has four REPL licenses available. There are businesses currently operating in Kodiak that have expressed interest in applying for one of the licenses held by the licensee. The City of Kodiak fully supports

#### CONCLUSION

The holder of expired REPL #3293 failed to timely submit a complete renewal application, and for good reason: The license has not been actively exercised in many years. Putting aside the many technical defects that preclude the board from reissuing REPL #3293, the spirit of the laws and public policy also militate against reissuing the license. A license issued under Title 4 is not a property interest. It is a privilege that must be actively exercised for the benefit of the public. This has not been true of REPL #3293 for many years and the applicant fails to show that the license would be so exercised were it reissued.

REPL #3293 expired. AMCO should give public notice that an REPL for a location in the City of Kodiak is available, providing all local entrepreneurs equal opportunity to obtain the privilege of operating the license. The board can then, in accordance with 3 AAC 305.105, select among the mutually exclusive and competing applications.

nominally identify the premises address as 116 Rezanof Drive. However, 3 AAC 305.120(f) must be interpreted to mean that that the application identifies (i) actual existing premises that (ii) are under the control of the applicant. In addition to other provisions,<sup>47</sup> the statutory definition of "licensed premises" demands as much.<sup>48</sup> If an applicant could satisfy 3 AAC 305.120(f) by simply identifying *any* premises, the requirement that the applicant identify a licensed premises location would serve no purpose.

The owner of the 116 Rezanof Drive property has informed the City that the applicant does not have a lease to premises at that property. The applicant's waiver applications tend to confirm as much. As the applicant's right to possess the identified premises is doubtful, the applicant should be made to produce evidence showing that the applicant has the right to possess the premises. Absent reasonable proof of the right to possess as 116 Rezanof Drive, the waiver applications should be denied because they do not identify a premises that the applicant has the right to possess. And if the Board were to reissue REPL # 3293, the applicant would necessarily need to immediately request waiver for 2024, which would indisputably be at least the third consecutive waiver, and 305.120(f) mandates that it "will be denied."

This letter is to inform you that the review of Liquor License # 2611 renewal application for Sizzler Burger and Peking Restaurant is scheduled to be heard by the Kodiak Island Borough Assembly on **August 1, 2024**. The meeting will start at 6:30 p.m. in the Borough Assembly Chambers at 710 Mill Bay Road, Kodiak.

According to Alaska Statutes 04.11.480, and regulations in 3 AAC 305.085, the local governing body has the authority to protest renewal of a liquor license for public policy reasons or due to license-related issues. Pursuant to KIBC 5.01.020 the Clerk's Office investigated and has been advised that circumstances relating to the license renewal application support an objection by the governing body in order to protect the Borough's interests. Specifically, the Borough has an interest in licensed premises having proper building permits and zoning, and an interest in the information set out in the license application being accurate and complete. Those interests are adversely impacted and need to be protected due to the absence of the correct business address on the application and the apparent lack of operations or permitting for work on the premises. The following particular concerns/interests were brought up:



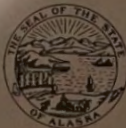

c. **Public Hearing on Resolution No. 2024-22, Protesting, Subject to Rescission, Renewal of Restaurant or Eating Place License No. 2611 for Sizzler Burger & Peking Restaurant**

The City of Kodiak scheduled a public hearing on Resolution No. 2024-22, a resolution protesting, subject to rescission, the renewal of restaurant or eating place license no. 2611 for Sizzler Burger and Peking Restaurant.

Deputy Mayor Stanford closed the regular meeting and opened the public hearing.

Leanna Harrington, owner of Bean and Bloom Coffee, spoke in support of Resolution No. 2024-22. She stated she has spoken to all members of the Council and the Manager's office and believes that Sizzler Burger & Peking Restaurant should not have their REPL license.

Deputy Mayor Stanford closed the public hearing and reopened the regular meeting.

V. **UNFINISHED BUSINESS**

a. **Resolution No. 2024-22, Protesting, Subject to Rescission, Renewal of Restaurant or Eating Place License No. 2611 for Sizzler Burger & Peking Restaurant**

Deputy Mayor Stanford read Resolution No. 2024-22 by title. This resolution to protest the renewal of the subject Restaurant or Eating Place License (REPL) application is on the floor from the regular Council meeting of July 25, 2024. State Law gives local governing bodies like the City of Kodiak and Kodiak Island Borough the opportunity to protest the approval of an REPL application with clear and concise reason within 60 days of receipt of the notice. At the August 6th regular meeting, a motion was passed to postpone approval of the resolution for 60 days to complete the open protest period allowed under State Law and deadline for the ABC Board to accept the protest of the renewal of the license.

In addition, since July 25<sup>th</sup>, the Finance Director worked with Sizzler Burger owners to review all supporting documentation and accepted amended sales tax returns from Sizzler Burger. The lack of these documents was the only legal basis for the renewal protest under city code. In the meeting packet was a letter to the business owner requesting supporting documentation, a June 11, 2024, letter from the Alcohol & Marijuana Control Office with the renewal application and a letter dated September 6, 2024, to the ABC Board from the Kodiak Island Borough requesting the ABC Board revoke the license held by Sizzler Burger.

Since procedurally, AMCO has closed this action and the 60 days to protest has come and gone, and the fact that the Finance Department has accepted amended sales tax returns and Kodiak

Starting middle of 2022 was also very challenging with hiring help in Kodiak. Attached photos of our local business with signs “closed short of employees” or “referral bonus” When finally got the help we needed

While we were not at the restaurant, the owner of the building came in and told new help that he was the owner of the building and he was going to evict us and he would not have a job for long.

At the same time, many Kodiak businesses were closing. Restaurant businesses without a place to go. El Chicano was one of them. Their building was sold to a new owner and he wanted to renovate and took time to build apartment upstairs and restaurant kitchen concrete to dry before being inspected.

Catering businesses that were renting the kitchen of the convention center were also struggling with convention center being taken down to build rooms.

There were and still are not enough restaurant equipped properties ( sprinkler, pipes, grease trap etc. to meet all the requirements for restaurants to rent. One space that was available was given to a cannery ( Silver Bay ) to rent to feed their employees. Having been a long-time resident in the city of Kodiak we also knew there were not enough restaurants like a “musical chair” and wanted to do what we could to keep restaurants stay in business. This too, was denied by the new landlord. Because we had a valid and legal lease until the end of 2026. We then helped one restaurant get into a property we were thinking of moving to.

It got harder after that with the owners doing everything that they can for us to operate our business as we always have.

Fall of 2023 We did a lot of research and flew to Seattle a few times and decided we were going to close the second floor starting January of 2024 and only have Sizzler burger Peking and put in golf stimulator with one sky track and a track man 4 IO for our talented golfers where 2nd floor space was. We were very excited because Mr. Kim and Mrs. Kim both have always believed physical recreation with Kodiak’s weather, and believed it helped mental health awareness.

With this plan, Mrs. Kim decided in September of 2023 to give the full-service restaurant serving beer and wine license she did not need any more to Nuniaq. They are/will be a full-service restaurant and they can utilize it appropriately and Serve Kodiak. They are honest, hardworking young Kodiak residents that have always wanted to open a restaurant of her own and she did.

When Tony came to measure for screen and location in December for the box and to build solid for safety of machine protection for golf stimulator, owner came in and said he is the owner of the property will not allow it.

But final draw for us to give up on our place was when part of the ceiling in back dining fell down from them doing work on the building in 2024.

We Paid rent every month. We paid KEA every month. We had full liability insurance of the business. Other utilities as well were all finally turned off at the end of March 2024.

People don't even Live in a house for 40 years.

We were heartbroken with packing all the memories, equipments, dishes, silverware, etc. of our 40 plus years of life this year but our safety was first.

We helped bring "Dominos", we brought Sushi to Kodiak. We brought "Sparrow's" when we didn't have any pizza in town. We helped Nuniaq find a home and have beer and wine with full a restaurant service. We hope to do more if we can. This includes finding a home for sizzler Peking until Mrs. Kim is ready to fully retire.

We have in the past 40years been prompt and paid on time.

With these unforeseen difficulties and challenges we were not able to operate as we have in the past.

We apologize for any inconvenience and we thank you for your time.

To: The Alcoholic Beverage Control Board,

The Kodiak City Council is lodging a protest with the Alcoholic Beverage Control Board for the continued use and operation of the Sizzler Burger & Peking Restaurant REPL License No. 2611. The City Council had limited documentation and lack of familiarity with Alcohol and Marijuana Control Office processes within the initial 60-day protest period set by AMCO. The City Council held a public hearing on October 10, 2024, following the postponement of the action from the July 25 and August 8, 2024, regular meetings. Stephanie Kim spoke during the meeting on August 8, 2024, to inform the Council of the challenges to re-open Sizzler Burger & Peking Restaurant.

Upon further review of the renewal application submitted by Sizzler Burger & Peking Restaurant dated December 26, 2023, the restaurant's application for renewal as stated in their forms AB-17 and AB-33 includes data for food and alcohol revenue generated in 2022 and 2023. The restaurant had originally filed \$0 on City sales tax returns for 2023. It is our understanding the City can protest the second year of continued operations pursuant to AS 04.11.480. Please accept this protest due to inconsistencies filed in their application while remitting taxes and inability to provide restaurant and eating place services while holding this license. A public hearing was held on this protest on October 24, 2024, during the City Council regular meeting at 6:30 p.m. in the Kodiak Public Library. Ms. Kim was notified of the meeting and her opportunity to participate.

REPL No. 2611 is currently designated as "active-temporarily surrendered" as a result of the loss of its operational location. It is well known that the restaurant has not operated for several years, including the years referenced in the application.

Kodiak has four REPL licenses available. There are businesses currently operating in Kodiak that have expressed interest in applying for one of the licenses held by the licensee. The City of Kodiak fully supports economic growth and development; therefore, the Kodiak City Council supports a protest of continued renewal of the REPL No. 2611 that is inactive and issued until December 31, 2025. We request that this matter be reviewed at the next Alcoholic Beverage Control Board meeting in November.

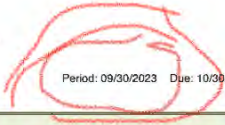

We are small business owners of Kodiak.

We are forwarding each one of you this e mail to show just one example of our journey on this matter with the city (this is only the tip of the iceberg)

Also the questions and statements made by each one of you at the August 8th council meeting made us realize again, the importance/knowledge, and intelligence of the city councils. We too had all those questions and statements to the city up until the day of the meeting with no return call/ no availability.

“Disagreeing with protest” “give them 30 days” “Did they make an effort?”

“Covid shouldn’t be the reason for other businesses are....”

“Suggestion of 60 days”

“I vote yes to 60 days because I don’t have enough information”

Richard,Bob absolutely. None of you including myself had enough information at that moment.

Example:

Was 8/08 meeting necessary?

Was the votes of the council even necessary?

If the city staff would have responded. If the city staff gave accurate information to the council members but more importantly to us. If the city staff did not give inaccurate directions.

We spent weeks trying to reach someone from the office.

No return calls, return emails, not being able to see them. We tried.

We went to city office and someone said “hi Mrs.kim” we told her the reason we were there. She told us to go down stairs to the clerks office. She never told us she was the Financial Director. Many days calling the office leaving messages for both the clerk and acting manger, one staff said “ you need to get in touch with Jennifer, the Finance Director ” the person that directed us down stairs was Jennifer the Financial Director. I responded no, because we saw her, left messages and she hadn’t so it has to be different department. The staff tracked her down and now she was forced to talk to us.

We finally speak for 3 minutes. Most of 3 minutes was her accusing us of false accusations. Told to submit the forms and said you have until the 8th.

We submitted the forms she instructed us to. We did not get response. Again, we call. We leave messages. We go to the city. She was never available.

8/08 later in the afternoon ( the day of the meeting)we get “ I am sorry - I am not aware of what you are talking about” if these are sales tax forms to go to sales tax department.

So go to the city. Staff are calculating the forms and when complete and we take our check book out,4:45 pm a gentleman comes over, with a piece of paper that the “Director” instructed to that we need different forms/process.

Our efforts in getting someone from the city to response included leaving voice messages, leaving a hand written contact information on the Finance Director’s desk, physically going to the city office and waiting for her with no success. We left messages with other employees as well.

“How can the City Council do the important/ honorable roles it is designed for our community including voting with missing/ limited/ misleading information by a city staff? “

“The city office staff are at an office with phone numbers that we residents/ business owners have access/ need and have the right to reach. However when they do not, how are we to try and resolve any problems? How are we to understand what the problem is? “

“Was 60 days even needed? Consumption of the last 3 long months time necessary if these things were done by a city staff with the title “Director” in the first place?

Since July, We are still waiting on answers/ response from the city. One of those is “filing in person”on certain dates of 2023. These are impossible. The letter we have written the city will also confirm this. Those dates we were researching new addition of business to bring to Kodiak and was physically in a different State.

Reason for this letter to all of you Council Members is in hopes and wish this type of behavior from the City and its staff does not happen again to any other residents and or business owners.

Question: “who”from the city office without factual information and research that is so available from the state and city office full of staff apply and misinform/ promise this license to People.

This “inauthentic”information stated by a city staff was the only reason our other local government meeting came to an end. Not the reasons stated on the letter “the business location has been “guttred” by the building owner “without any permits” being one of the reasons. Which goes into why we suffered after the pandemic. We stayed and tried to until this year because it was our home and had rights to with a valid contract and paying until part of the ceiling fell.

The only answer I have gotten to “who” is “the city council”

There is an enormous grieving and outraging emotions to few people including our local governments for a “loss” of Restaurant/ eating place beer and wine license falsely promised that “never” had an existence.

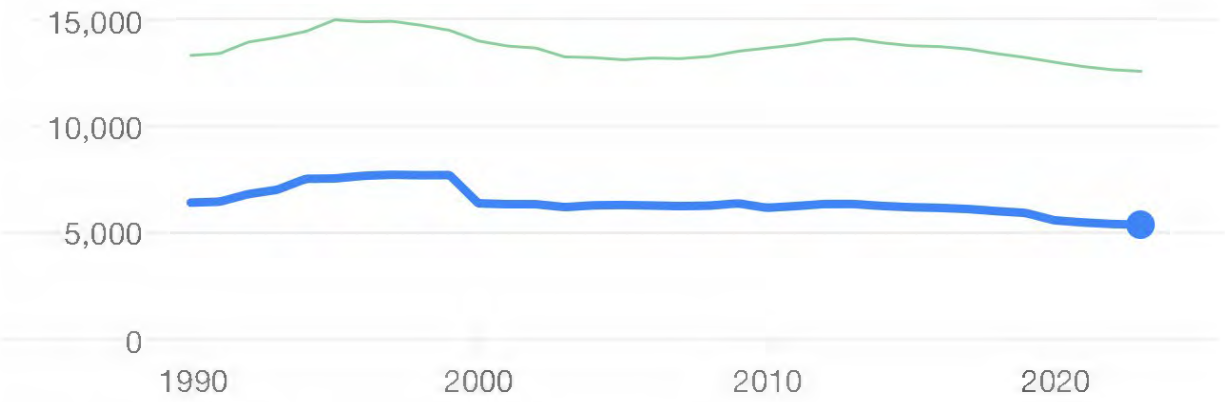

expansion in coming years, adding to the growing development of this town. In addition to the military, we also still have logging and the Alaska Aerospace Corporation and Launch Complex, bringing additional working possibilities to our town.

Along with the working industry, our island also welcomes many out-of-town leisure visitors including sport fishermen and hunters, travelers, and several large cruise ships each Spring and Summer well into the Fall season. In 2018, Kodiak saw approximately 64,000 visitors that included 38,000 independent travelers and 26,000 cruise ship passengers. In 2024, we have 24,230 cruise passengers alone spanning over 22 different days throughout the seasons coming to visit our town which greatly impacts and adds to our local economy and small businesses.

We, including residents, seasonal employees, visitors, etc., have six brick + mortar restaurants on our road system open year round to the public. As I have explained, there is a growing demand for social gathering venues as Kodiak continues to welcome guests and visitors alike while continuing to grow and expand. Out of these six restaurants, there are four permit holders for restaurant beer & wine exclusively, with only three for current public use. I feel as though providing more will not only increase business opportunities in our town but also open the door to more creativity and city development, increasing revenue and generating more taxable income for the city of Kodiak and through the Alaska alcohol tax. Beyond business development and increased revenue, allowing more permits also gives people more local options and establishments to enjoy and use while hopefully providing more of a draw for our annual out-of-town visitors and workers. I, as much as a lot of residents, would love to see our small town grow, thrive, and expand. While providing additional services and establishments for Kodiak, more permits allow for more job opportunities, more food/eatery options, and additional revenue in both our community and for the City of Kodiak.

There are two cities in the State of Alaska that haven't taken advantage of the Restaurant or Eating Place Licenses since the titles passed. Both Wasilla and Valdez have been granted a total of at least 25 additional REPL's. I am reaching out asking for the City of Kodiak to consider following this lead to petition adding more licenses with beer and wine to benefit our ever-growing and hospitable community in hopes of generating more income, job opportunities, and establishments that the community can all enjoy.

**c. Public Hearing on Resolution No. 2024-22, Protesting, Subject to Rescission, Renewal of Restaurant or Eating Place License No. 2611 for Sizzler Burger & Peking Restaurant**

The City of Kodiak scheduled a public hearing on Resolution No. 2024-22, a resolution protesting, subject to rescission, the renewal of restaurant or eating place license no. 2611 for Sizzler Burger and Peking Restaurant.

Deputy Mayor Stanford closed the regular meeting and opened the public hearing.

Leanna Harrington, owner of Bean and Bloom Coffee, spoke in support of Resolution No. 2024-22. She stated she has spoken to all members of the Council and the Manager's office and believes that Sizzler Burger & Peking Restaurant should not have their REPL license.

Deputy Mayor Stanford closed the public hearing and reopened the regular meeting.

Councilmember Whiddon stated that the Fisheries Work Group is planning to have a meeting on October 23, 2024.

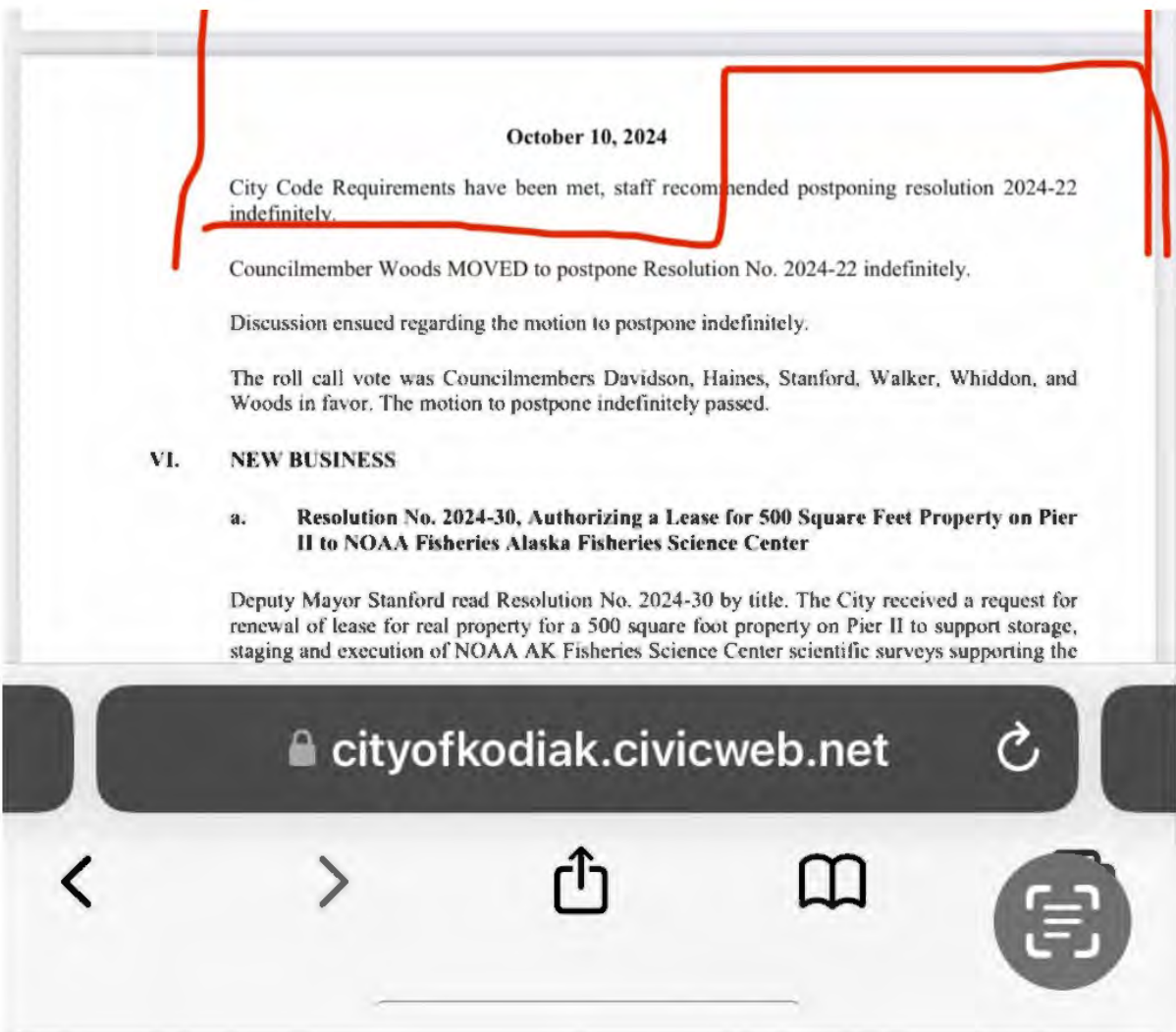
**V. UNFINISHED BUSINESS**

**a. Resolution No. 2024-22, Protesting, Subject to Rescission, Renewal of Restaurant or Eating Place License No. 2611 for Sizzler Burger & Peking Restaurant**

Deputy Mayor Stanford read Resolution No. 2024-22 by title. This resolution to protest the renewal of the subject Restaurant or Eating Place License (REPL) application is on the floor from the regular Council meeting of July 25, 2024. State Law gives local governing bodies like the City of Kodiak and Kodiak Island Borough the opportunity to protest the approval of an REPL application with clear and concise reason within 60 days of receipt of the notice. At the August 8th regular meeting, a motion was passed to postpone approval of the resolution for 60 days, well past the open protest period allowed under State Law and deadline for the ABC Board to accept the protest of the renewal of the license.

In addition, and since July 25<sup>th</sup>, the Finance Director worked with Sizzler Burger owners to review all supporting documentation and accepted amended sales tax returns from Sizzler Burger. The lack of these documents was the only legal basis for the renewal protest under city code. In the meeting packet was a letter to the business owner requesting supporting documentation, a June 11, 2024, letter from the Alcohol & Marijuana Control Office with the renewal application and a letter dated September 6, 2024, to the ABC Board from the Kodiak Island Borough requesting the ABC Board revoke the license held by Sizzler Burger.

Since procedurally, AMCO has closed this action and the 60 days to protest has come and gone, and the fact that the Finance Department has accepted amended sales tax returns and Kodiak
