Dear Members of the Alaska Alcoholic Beverage Control (ABC) Board,

I am writing to respectfully request that the Alaska ABC Board reconsider its decision regarding the prohibition of trivia nights at my brewery, Baleen Brewing Co. LLC. I believe this policy infringes upon my First and Fourteenth Amendment rights, particularly as they pertain to free speech, and I would like to present my argument as to why this activity should not be categorized as a "game" but rather as a form of protected speech.

While I understand the ABC Board's position on limiting activities that may be classified as "games," I respectfully submit that trivia nights are not primarily games in the conventional sense, but rather forms of intellectual expression, discourse, and engagement. The act of hosting a trivia night goes beyond simply providing a "game" to customers—it involves the sharing of information, the exchange of ideas, and the expression of knowledge. This is, fundamentally, an exercise of free speech.

# First Amendment: Freedom of Speech

The First Amendment of the United States Constitution guarantees the right to free speech, and this protection extends to all forms of communication, including verbal, written, and even interactive expression. The State of Alaska also guarantees these rights under Article I, § 5-Declaration of Rights. Trivia nights, while they may involve competitive elements, are a vehicle for speech and expression. The questions posed during trivia may address a wide range of topics—from history, science, and literature to pop culture and current events—and they serve to encourage dialogue and exchange among participants. This is a fundamental exercise of free speech, not a mere game of chance or skill.

Courts have consistently held that certain activities that may seem like games or entertainment are, in fact, protected under the First Amendment when they involve speech or expression. Brown v. Entertainment Merchants Association (2011) Joseph Burstyn, Inc. v. Wilson (1952) In Hurley v. Irish-American Gay, Lesbian, and Bisexual Group of Boston (1995), the Court held that speech doesn't need to convey a particularized message to qualify for protection; even entertainment can be considered speech. For example, various forms of public speaking, artistic 10

performances, and even games with expressive content have been upheld as forms of speech. Trivia nights at my brewery operate in a similar vein, as they create a space for individuals to express their knowledge, engage in cultural exchange, and partake in intellectual discourse.

# Fourteenth Amendment: Equal Protection Under the Laws

The Fourteenth Amendment guarantees that no state shall "deny to any person within its jurisdiction the equal protection of the laws." By prohibiting trivia nights at my brewery, the state is treating a form of protected speech differently from other forms of speech that may occur in social settings, such as live music, open-mic nights, or other public events. These events are permitted in bars and taverns but are prohibited in breweries. This is an infringement on my 14<sup>th</sup> amendment right of Equal Protection Under the Laws.

Disallowing trivia nights creates an unequal standard where intellectual speech is restricted, while other forms of entertainment and social engagement are permitted. This discriminatory application of regulations undermines the very principles of equal protection and fairness enshrined in the Fourteenth Amendment.

### Conclusion

In conclusion, I respectfully ask the Alaska ABC Board to reconsider its stance and allow trivia nights at Baleen Brewing Co. LLC as a legitimate form of free speech under the First and Fourteenth Amendments. I believe that trivia nights are a valuable cultural activity that promotes the exchange of ideas and fosters community engagement. The prohibition of these events, based solely on the classification of trivia as a "game," overlooks the fact that they are inherently expressive and educational.

I would be more than willing to meet with the board or provide any additional information or clarification to support my position. Thank you for considering this request, and I look forward to your favorable response.
