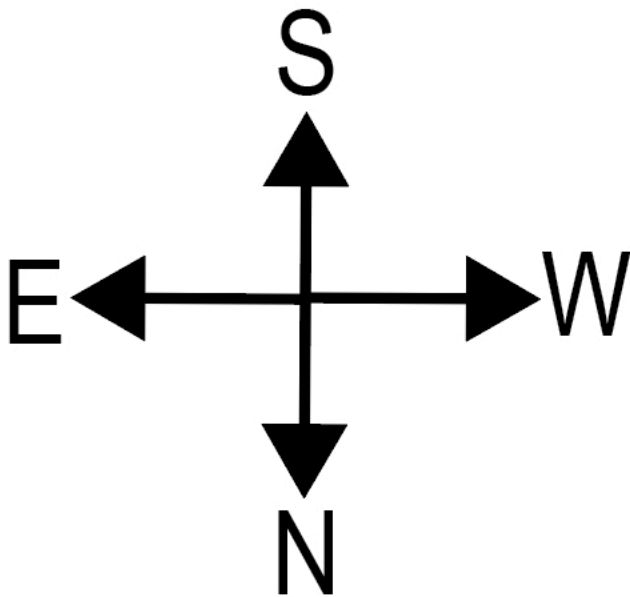

The patio area for Buzzed Beetle Brewery, will be roped off with chains attached to 3-foot-high stands. This outside space will be utilized from May 1st to Sept 30th.

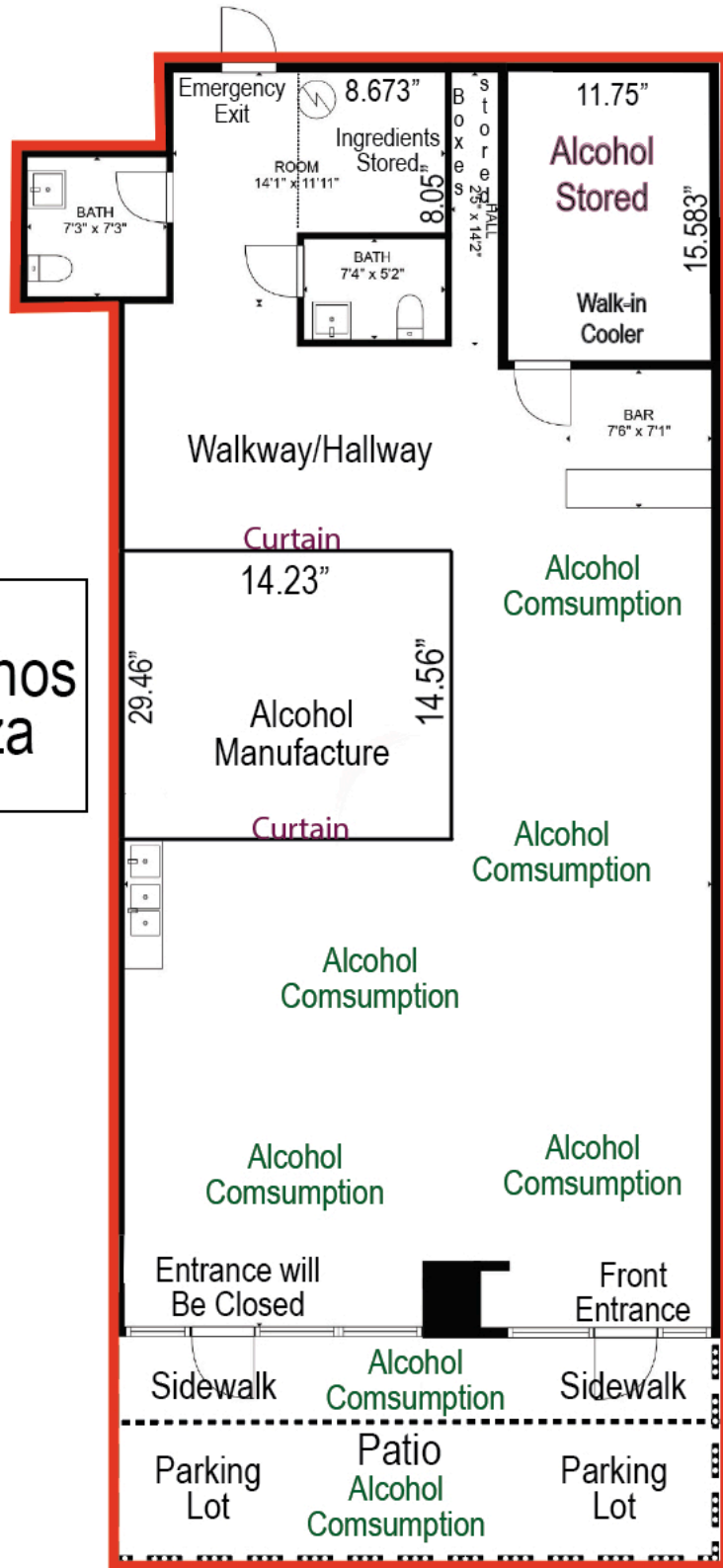
When the area is occupied a staff member will be present during the entire duration of occupancy. Identification will be checked to see who is of legal drinking age. If someone under the age of 21 is accompanied by a parent or spouse they will be able to enter the patio but they will be informed that they are not allowed to have access to alcoholic beverages and staff member will observe to make sure that they do not violate the underage drinking laws.

Each guest that is on the patio will be monitored to ensure that no underage drinking is being permitted. If such actions are observed, a cease and desist of said actions will be given to parties that are in violation of the underage drinking laws. An incident report will be filled out and kept on premises and any video footage that may contain said actions will be marked and saved and annotated on the incident report, that there is a video footage of violation.

Both parties will then be asked to leave the premises as they are in violation of the underage drinking law.
