● **LEGISLATIVE TRACKING**

- HB 37
  - ALCOHOL WARNING SIGNS ON LIC. PREMISES
  - "An Act relating to the posting of warning signs for Alcoholic Beverages"
  - HB 37 reduces the number of signs from 3 to . The pregnancy sign is amended to add cancer language. The AS 04.16.049(e) and AS 04.16.051 signs are combined into one.
  - Referred to House Labor and Commerce on 1/22/2025
  
- HB 68
  - ALCOHOL: SALE, WARNING SIGNS
  - "An Act relating to the sale of alcohol; and relating to the posting of warning signs for alcoholic beverages."
  - HB 68 provides for the employment of persons under 21 on certain licensed premises and includes cancer language on the pregnancy warning sign. It also broadens the club license.
  - Referred to House Health and Social Services on 1/31/2025
  
- HB 155
  - ALCOHOL SALES: LOCAL OPTION

- “An Act relating to alcohol; relating to local option elections; relating to the statewide database of alcohol purchases; relating to alcohol licenses, endorsements, and permits; relating to municipal regulation and taxation of alcoholic beverages; and providing for an effective date.
- HB 155 amends existing statutes to add certain licenses to the exception to prohibition in local option.
- Referred to House Community and Regional Affairs on 3/26/2025
- SB 15
  - ALCOHOL: SALE, WARNING SIGNS
  - “An Act relating to the sale of alcohol; relating to the posting of warning signs for alcoholic beverages; and providing for an effective date.”
  - SB 15 provides for the employment of persons under 21 on certain licensed premises and includes cancer language on the pregnancy warning sign.
  - As of April 4<sup>th</sup>, awaiting transmittal to Governor.
