Re: Petition application under AS 04.11.460(a) for a new Beverage Dispensary license #60033 d/b/a Tangle Lakes Lodge.

Licensee applicant Tawnia Butorac is applying for a new Beverage Dispensary AS 04.09.200 license located at Mile 22 Denali Highway. This location is in an area outside but within 50 miles of the boundaries of a local governing body.

**Relevant Statutes:** 

The application falls under AS 04.11.460(a).

**AS 04.11.460. Prior public approval.** (a) A new license or the transfer of location of an existing license may not be approved by the board in an area outside but within 50 miles of the boundaries of a municipality unless a petition asking that the license be issued or transferred within the area containing signatures of a majority of the permanent residents residing within one mile of the proposed premises is filed with the board.

The premises location 'Mile 22 Denali Highway' is estimated to be 14.23 miles from the Matanuska-Susitna Borough boundary.

(AS) Title 29, Chapter 29.04.010, states that a municipality is a political subdivision incorporated under state law, including boroughs.

The applicant provided an affidavit that there are no permanent residents within a mile radius of the proposed premises.

The application is allowed under As 04.11.400(a).

**AS 04.11.400. Population limitations.** (a) Except as provided in (f), (i), and (k) of this section and AS 04.11.405, a new license may not be issued and the board may prohibit relocation of an existing license

(1) outside an established village, incorporated city, unified municipality, or organized borough if, after the issuance or relocation, in a radius of five miles of the licensed premises, excluding the populations of established villages, incorporated cities, unified municipalities, and organized boroughs that are wholly or partly included within the radius, there would be

(A) more than one restaurant or eating place license for each 1,500 population or fraction of that population;

(B) more than one brewery retail, one winery retail, and one distillery retail license for each 9,000 population or fraction of that population; or

(C) more than one license of each other type, except a type listed in (i) of this section, for each 3,000 population or fraction of that population;

AMCO shows that there are two active alcohol licenses within a 5 mile radius of the proposed premises location at Mile 22 Denali Highway. Both active alcohol licenses are located at Mile 20 Denali Highway.

- 1. Package Store license 1117 dba Tangle River Inn
- 2. Beverage Dispensary Tourism license 1116 dba Tangle River Inn

Licensee applicant Tawnia Butorac is **not able** to apply for a new Package Store license as this is excluded under AS 04.11.400(a)(1)(C). Her application for a new Package Store license at the proposed premises Mile 22 Denali Highway is withdrawn.

Licensee applicant Tawnia Butorac **is able** to apply for a new Beverage Dispensary license AS 04.11.200 as there is no existing active license of this type within a 5 mile radius.

The existing active Beverage Dispensary Tourism license #1116 located within the 5 mile radius is not counted per AS 04.11.400(a) and specifically excluded per AS 04.11.400(i).
