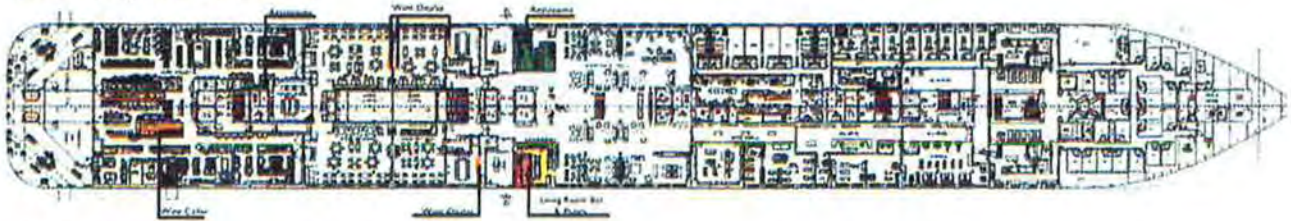

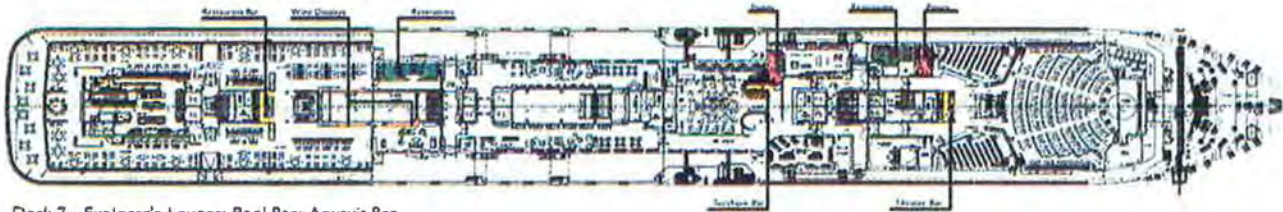

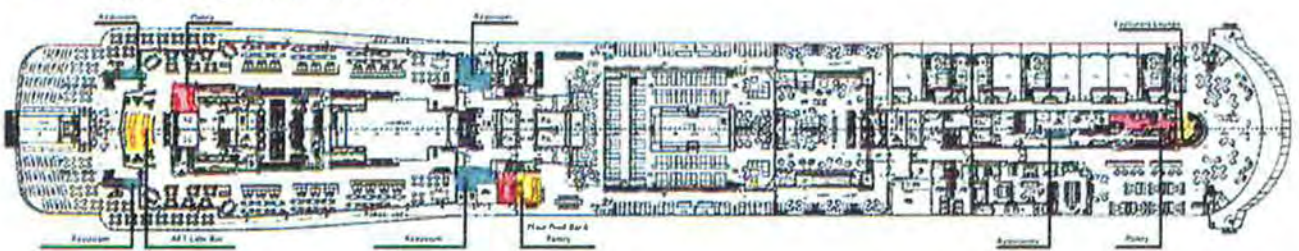
Deck I - Living Room Bar; Wine Cellar



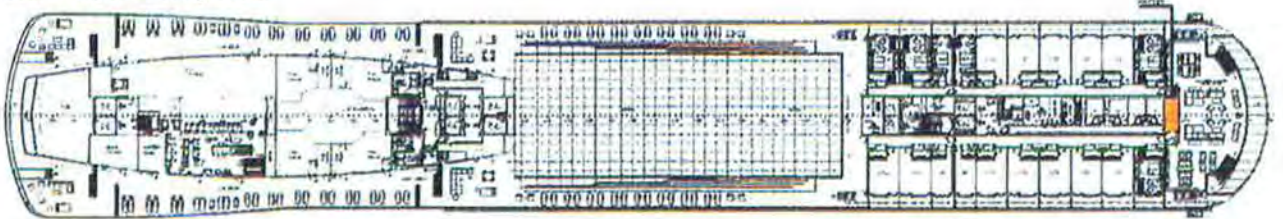
Deck 2 - Theater Bar; Torshavn; Restaurant Bar



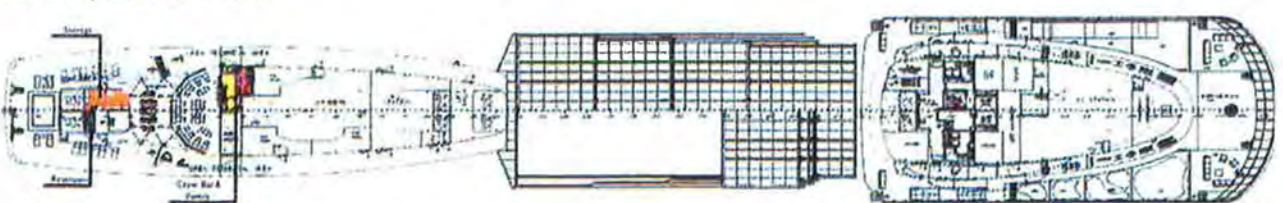

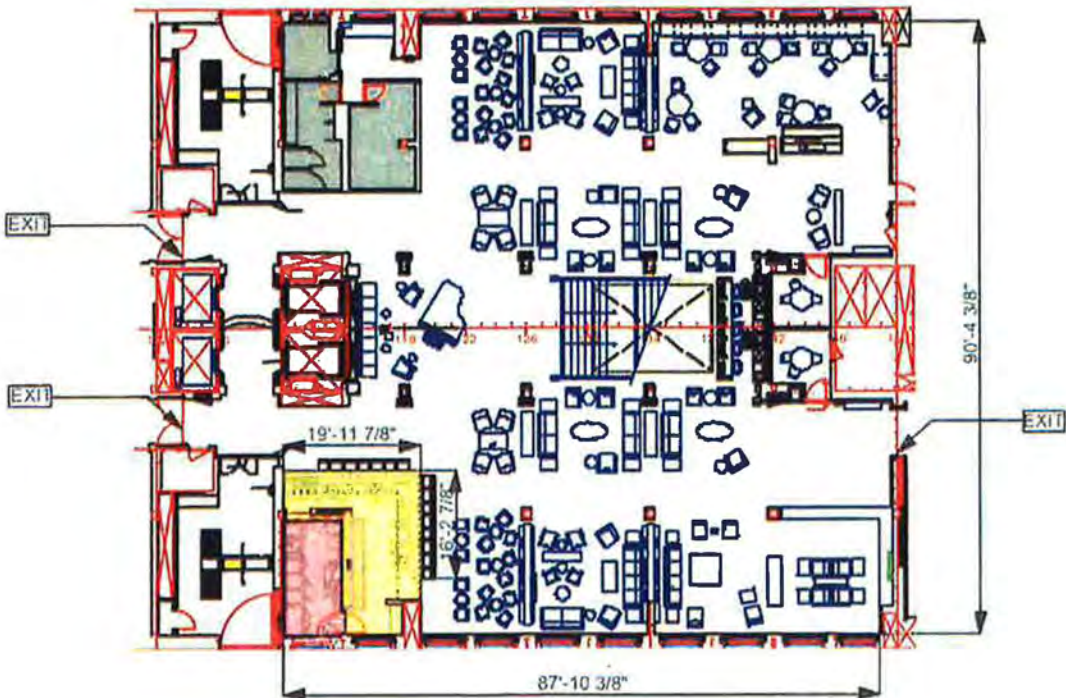

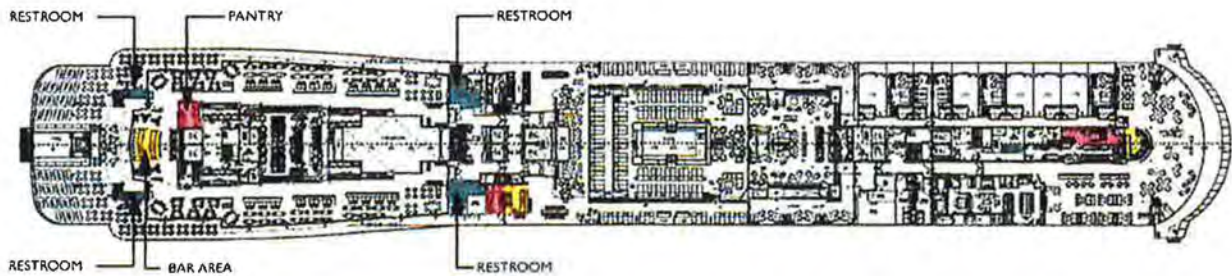
